#### **TRAIN**

From the station of NAPOLI CENTRALE, take the subway LINEA METROPOLITANA 2 direction POZZUOLI SOLFATARA, go out on the last station in POZZUOLI and you will find the venue 5 min. walk from the station.

#### **AIRPLANE**

From and to the international airport of NAPOLI CAPODICHINO we offer a private transportation service at the cost of 70 € return

#### **ACCOMMODATION**

No amount already paid relating to the first installment or the entire balance of the "Accommodation" option will in any case be refunded, as specified below in the "Terms and Conditions".

#### **REGISTRATION**

2) PAYMENT OF 50% OF THE TOTAL BY BANK TRANSFER TO THE SEPARATELY INDICATED BANK DETAILS.

5) PAY THE REMAINING BALANCE **NO LATER THAN MONDAY MAY 1<sup>ST</sup> 2023** AND SEND A COPY OF THE TRANSFER TO THE ABOVE EMAIL ADDRESS.

#### **TERMS OF PAYMENT**

Upon completion of the application, the Dancer, at the same time as signing this registration form, is required to pay 50% of the fee resulting from the sum of the options and services chosen and to attach a copy of the bank transfer made to the Registration Form sent by e-mail, as indicated above. The balance of the remaining fee must, however, be paid by the Dancer by Monday 1st May 2023, after having received confirmation from the Organizer of admission to the event.

If the Candidate fails to pay by that date, the relative application will not be considered completed and, therefore, will not be examined for selection purposes.



The sum already paid will be transformed into a voucher that can be used - no later than 31 December 2023 - on the occasion of future events organized by the Organizer, but no refund will be granted to the Candidate. Only in the event that the Candidate should not be admitted by the Organizer to take part in the event due to the numerical limit of the places available, the latter will be reimbursed within the limits of the fee already paid at the time of registration.

# GENERAL AGREEMENT BETWEEN THE DANCER AND THE ORGANIZER OF THE EVENT

("THE ORGANIZER"):

By signing this Registration Form, the Dancer - or, if a minor, his parent/legal guardian - accepts the following Participation Regulations and the relative Clauses contained in the "Terms and Conditions".

#### **REGULATION**

(Available places are limited, therefore the Organizer reserves the right to select the Dancers who will apply)



YOUR FIRST STEP TOWARDS SUCCESS

- 1) The purpose of the Organizer is to offer young professional dancers the opportunity to audition before several Artistic Directors or their official Representatives in order to obtain a position within the relevant Companies and/or Academies.
  - 2) The Dancer who intends to send an application through the online portal (www.gcdancevents.com), must make sure to contact the Organizer if, after 7 days, the relative registration is still not confirmed by e-mail.
  - 3) The Dancer will be assigned a number at the time of registration, which must be shown and worn throughout the duration of the event; the number that will be assigned will represent the Dancer's file and, during the auditions, the latter will be identified only through that number. (THE LOSS OF THE NUMBER WILL INVOLVE THE PAYMENT OF A PENALTY OF 5 EUROS).
  - 4) The Dancers will be divided into two groups, so that the classes are not too crowded. Any request to change the group and/or group mates will not be accepted.
  - 5) No delays will be tolerated: if, for any reason, the Dancer shows up more than 5 minutes late, he/she will not be able to access his/her class.
  - 6) The Dancer is reminded that his/her presence at the event does not guarantee him/her any offer or admission: the Organizer offers the intensive week of workshops with Artistic Directors who, after having carefully analyzed each one's profile while participating in the event, they could offer the Dancer whatever they see fit. It is solely up to the jury to make any decision.
  - 7) The final auditions will be held on Saturday 8 July: any type of result, offer or comment will not be announced or formulated on the day of the auditions; if the Dancer's number is selected for any type of offer or admission, the Dancer will be notified within 15 days and will be put in direct contact with the organization concerned.
  - 8) Access to the venue is forbidden to friends or relatives, unless authorized.
  - 9) Please speak to one of the Organizer's team members for any indications, information or clarifications: the team speaks ITALIAN, ENGLISH, FRENCH, BULGARIAN AND SPANISH.
  - 10) It is forbidden for the Dancer to speak to any Member of the Jury, unless approached.
  - 11) The Artistic Director of the Organizer will personally contact the Dancers who have chosen the "Photo Service" and/or "Audition Portfolio" option, to fix the relative appointments.
  - 12) Dancers who have chosen shared accommodation will be assigned a shared room and, as indicated above, no changes will be made for any reason, except in the exceptional cases indicated above.
  - 13) A bar will be available at the venue to provide drinks, snacks and guick meals.

- 14) The Dancer is requested to free up his or her place in the changing rooms at the end of each day.
- 15) The jury may select some candidates for further auditions and request some candidates to leave the audition earlier than expected.
- 16) The judging panel may request further material to be viewed at the end of the event to confirm or re-evaluate a possible outcome.
- 17) the Organizer has the right to replace any member of the jury, any such changes will not interfere in any way with the quality and professionalism of the services offered.

#### **TERMS AND CONDITIONS**

- 1) By signing this Registration Form, the Dancer or, if a minor, his parent/legal guardian authorizes the Organizer to:
- a) process and/or transfer, for the agreed audition a342nd recording services and for any other service or activity connected to them, your personal data pursuant to Legislative Decree 30 June 2003, no. 196 and of the EU Regulation n. 2016/679; b) use the photographic and video recordings (photos, video material, etc...) taken during the event for future advertising purposes and, in general, to exercise one's right to the image for any purpose connected to the previous purposes and to those to which this Agreement is preordained.
- 2) Dancers and their parents/legal guardians who select and use the "shared accommodation" option even though the structure identified by the Organizer is supervised by internal staff and, in the case of the participation of unaccompanied minor Dancers, attended by adults of the organizing team will be responsible for their own personal belongings and for their own safety and security.
- 3) The Dancers and their parents/legal guardians who will participate in the event exempt, release and hold harmless in advance and expressly the Organizer and his organizational team from any civil liability, even objective excluding mandatory cases of liability for willful misconduct or gross negligence for any accidents or injuries, death or injury, illness or personal and property damage suffered by anyone and in any way or to anyone/anything and in any way caused, as a consequence and/or on the occasion of participation in the aforementioned event or, in any case , deriving from the execution of this Agreement (damage to persons and/or property of third parties, damage to equipment, loss or theft of personal effects, etc...).
- 4) Consequently, in application of the previous contractual clause, the Dancers and their parents/legal guardians expressly and in advance waive the right to claim any



future compensation claim for the aforementioned damages and to initiate any related judicial and/or arbitration action aimed at obtaining the any compensation, settled

here. Therefore, with the exception of the hypotheses indicated above, the Organizer and her team will not be held personally, financially, legally and / or judicially

responsible for anything.

5) The Dancer who will participate in the event declares to be aware of the condition whereby, in all cases in which he should be prevented from participating in all or even part of the event for reasons attributable to him/her (e.g. delay, unlawful conduct, cancellation, etc...) or for a cause, in any case, not attributable to the Organizer and/or its organizational team by way of willful misconduct or gross negligence, no refund will be granted. Similarly, the Dancer - after signing this agreement - may also add more services to his/her program, but may not request the replacement and/or change of any of the options already selected, nor request the Organizer, therefore, any type of reimbursement.

- 6) If the Candidate fails to pay by that date, the relevant application will not be deemed completed and, therefore, will not be examined for selection purposes. The sum already paid will be transformed into a voucher that can be used no later than 31 December 2023 on the occasion of future events organized by the Organizer, but no refund will be granted to the Candidate. Only in the event that the Candidate should not be admitted by the Organizer to take part in the event due to the numerical limit of the places available, the latter will be reimbursed within the limits of the fee already paid at the time of registration.
- 7) Anything not expressly selected by the Dancer when signing the Registration Form or anything, in any case, not expressly provided for in this Agreement does not form part of the relationship between the Organizer and the Dancer and cannot, therefore, be in any way or any venue claimed by the Dancer against the Organizer.
- 8) In all cases in which the Dancer admitted to the event will not be able to take part, the Organizer will not recognize any reimbursement: therefore, to the Dancer who, while giving notice to the Organizer, will not be present for second thoughts, health reasons (even Covid or simple positivity to any Coronavirus detection test), logistical problems, deaths, transfers, or any other reason impeding your presence at the event at the event venue within one hour from the start time (which will be communicated in any case before the start of the event), no refund will be recognized, and the sums already paid will be transformed into vouchers that can be used no later than 31 December 2023 on the occasion of future events organized by GCDANCEVENTS, but no reimbursement will be recognized to the Candidate.
- 9) For any dispute that may arise between the Dancer and the Organizer and/or a member of his organizational team as a consequence and/or on the occasion of participation in the aforementioned event or, in any case, deriving from the execution



and/or interpretation of this agreement, the Court of Naples will be considered exclusively competent.

10) Assumption of the Risk of Participation and Use of the GCDANCEVENTS spaces The Dancer declares to be aware of the fact that - by virtue of the type of activity carried out during events such as the one organized by GCDANCEVENTS - the risks associated with the activities, entry and use of the spaces made available by the Organizer or however, set forth in this Agreement may be both foreseeable and unforeseeable and may, therefore, include death and/or serious bodily injury, personal and patrimonial damage to yourself and to third parties, and you agree to assume all risks associated with them. Therefore, as a further specification and confirmation of what is expressed in point n. 3), the Dancer – or, if a minor, his/her parent/legal guardian – expressly declares, by signing this Agreement, that he/she accepts the assumption of full responsibility and risk of personal injury, death or damage to the person and/or or to its own property or that of third parties relating to or, in any way, deriving from the activities, entry and/or use by the Dancers of the spaces made available by the Organizer or, in any case, provided for by this Agreement.

#### 11) Insurance

For further specification and confirmation of what is expressed in point n. 3), The Dancer – or, if a minor, his/her parent/legal guardian – undertakes to indemnify and hold harmless the Organizer and/or agents, employees, directors of GCDANCEVENTS and any other member of the organizing team for any loss, theft, claim, damage, cost or expense which we may possibly incur for any damages, death and/or personal injury and/or property damage caused – as a result of or during the GCDANCE SUMMER AUDITIONS and/or any GCDANCE related activity SUMMER AUDITIONS – by the Dancer, by third parties or caused in whole or in part by the negligence/imprudence/skillfulness of the Organizer and/or its organizational team (except for the already mentioned cases of liability for willful misconduct or gross negligence), including legal costs and any procedural costs incurred for legal or arbitration actions deriving therefrom.
